# ANNUAL REPORT TO PARLIAMENT

PRIVACY ACT

REPORTING PERIOD: APRIL 1, 2014 TO MARCH 31, 2015

#### Introduction

The *Privacy Act* provides Canadians with protection and the right of access to personal information about themselves in records under the control of government institutions. Except in limited and specific situations, the right of access to one's own personal information under the control of a government institution cannot be restricted.

The Prince Rupert Port Authority ("PRPA") is a Canadian port authority established by virtue of Letters Patent, issued by the Minister of Transport pursuant to Section 8 of the *Canada Marine Act* (the "CMA").

PRPA was added to the Schedule of the *Privacy Act* (the "Act") and pursuant to section 72, PRPA has prepared its annual report on the application of the Act within the organization to be tabled in Parliament by the Minister responsible.

PRPA is responsible for administering activities within the Port of Prince Rupert related to shipping, navigation, transportation of passengers and goods and the handling and storage of goods, with a mission to develop and grow the Port of Prince Rupert in an aggressive, economical, safe and environmentally sound manner.

#### **Privacy Act Responsibilities**

The President and Chief Executive Officer of the Prince Rupert Port Authority Don Krusel is the Head of the Institution of the purposes of administering the *Privacy Act.* Mr. Krusel's responsibilities under the Act have been designated to Andrew Mayer, Vice-President, Commercial and Regulatory Affairs and General Counsel. The Access to Information and Privacy Coordinator and contact person is Nicole Murray, Administrative Assistant, Commercial and Regulatory Affairs.

#### **Privacy Act Statistical Report**

PRPA received no formal *Privacy Act* Requests ("Requests") during the reporting period April 1, 2014 to March 31, 2015. There were no Requests outstanding from the previous reporting year. A multi-year trend continues where by PRPA has not received any formal Requests.

Attached is the Statistical Report for detailed summary of data on *Privacy Act* Requests between April 1, 2014 and March 31, 2015.

#### Training

PRPA did not undertake any training activities during the reporting period April 1, 2014 to March 31, 2015.

#### **Policies and Guidelines**

#### **Privacy Complaints and Breaches**

#### Procedures

Procedures are in place for directing all formal requests and enquiries to PRPA's ATIP Coordinator, under the supervision of Andrew Mayer the delegated head of the program, who ensures that Requests are processed in accordance with the provision of the Act.

The ATIP Coordinator monitors the processing time of the Requests and reports regularly to the delegated head of the program. The Coordinator is responsible for ensuring that responses to Requests are handled in a timely manner, in compliance with the Act and endeavors to respond to Requests within the 30 day statutory timeline.

PRPA did not undertake any Privacy Impact Assessment activities during the reporting period.
