1. Call to Order

Maynard Angus called the meeting to order at 5:02 pm.

2. Last Meeting

a) Minutes

The October 15th, 2014 minutes were circulated and accepted.

b) Business arising from the minutes

- i. PRPA publish CIF meeting minutes on PRPA's website Maynard Angus reported that the minutes will be posted on its new website in a few weeks.
- ii. Light pollution concerns expressed were passed on to the management at Westview Terminal.

3. PRPA's Environmental Monitoring Program

Maynard Angus introduced Jason Scherr, PRPA's Manager of Environmental Sustainability.

Mr. Scherr's presentation reviewed some of the initiatives of PRPA's Environmental Stewardship Program, highlighting PRPA's role and the value it provides to the coastal communities.

The presentation included the following:

- Marine Water Quality sampling program
- Aquatic Invasive Species monitoring Program; in partnership with NWCC, Smithsonian and DFO.
- Emission and Energy Inventory. The inventory breaks emissions into five categories of:
 - o Administration office energy and lighting
 - Onroad Vehicles operating at and between the terminals
 - o Rail
 - o Cargo Handling Equipment Loaders, stackers/cranes, off-road trucks.
 - Marine OGV, Pilot boats, tugs.
- Green Wave Program PRPA's Environmental Inventive Program for Vessels offering reduced harbor dues for vessels with increased environmental performance..
- Green Marine Program, an industry led environmental program with collaboration
 with regulators, NGOs and academics to improve the performance of the marine
 shipping industry. The majority of PRPA's tenants and users have joined the program
 and supported by related environmental and educational institutions; and
 companies doing business at the port.
- Cow Bay Marine Restoration Concept Design provided on a potential stewardship project by the PRPA.

It was recommended that PRPA consider the creation of a library that could be a central hub for monitoring data collected from the region and accessible on PRPA's website.

4. RRUC Tour followup

It was requested that PRPA provide information on the RRUC project for the public to view. Maynard Angus reported that plans are underway to display story boards and a video in the Port's Interpretive Centre.
